Hicks co-wrote the original CCDS exam, serves on the ACDIS CCDS-O Certification Board, is the social media coordinator of the North Carolina ACDIS board, and was 2019 ACDIS Professional of the Year.
- Joy Bombay, RN, MSN, MHA, CCDS, is inpatient manager for CDE at Atrium Health Wake Forest Baptist. She holds a clinical/leadership position that coordinates all activities related to compliance, denials management, mortality reviews, and quality assurance as well as education with the CDE team and providers. Her CDI career started in 2014 after she spent 20 years in bedside nursing, providing care in the acute care setting as well as nursing leadership.
